**Article 1.** To act on the reports of the Town Officers as published in the Town Report?

**Article 2.** To elect the following officers:

Town Moderator (1 year term)  
Constable (1 year term)  
Select Board (3 year term)  
Delinquent Tax Collect (1 year term)  
Cemetery Commissioner (3 year term)  
Lister (3 year term)  
Trustees of Public Funds (1, 2 & 3 year terms)

**Article 3.** Shall any general fund surplus from the current fiscal year (2020-21) be applied to reduce taxes in the fiscal year 2021-22?


**Article 4.** Shall the Select board be authorized to borrow money in anticipation of receipt of taxes?

**Article 5.** Shall the legal voters of the Town approve the budget for 2021 in the amount of \$533,971.00 to meet the expenses and liabilities of the Town, of which it is estimated \$435,871.00 will be raised by taxes, \$6,000.00 will be covered by highway surplus, and \$92,100.00 will be raised by non-tax revenue?

**Article 6. ADVISORY ARTICLE ONLY (Non-Binding)** Shall the Select board relocate the Isle La Motte Town Offices to the Isle La Motte Elementary School building in anticipation of the Town's acquisition of the School property?
