Article 1. To elect by Australian Ballot the following Officers:

Town Clerk (3yrs.)

Town Treasurer (3yrs.)

Town Moderator (1yr.)

Constable (1yr.)

Select Board (3yrs.)

Delinquent Tax Collector (1yr.)

Representative for CIUUSD (3yrs.)

Trustee of public Funds (3yrs.)

Article 2. Shall the legal voters of the Town approve a budget of \$586,208.00 this includes all Articles as approved by the Select board to meet the expenses and liabilities of the Town for 2022: \$418,892.00 to be raise by taxes, \$11,386.00 to be covered by General Fund Surplus, and \$155,930.00 by Non-tax revenue?

The Articles for 2022 total \$48,542.00 (already included in the budget amount).

Article 3. Will the legal voters of the Town vote to apply any general fund surplus from the current fiscal year to reduce taxes in the next fiscal year?

Article 4. Will the legal voters of the Town authorize the Select board to borrow in anticipation of taxes?

Article 5. Shall the legal voters of the Town vote to mail the annual town report to the voters ten (10) days before the annual Town meeting?

Article 6. **ADVISORY ARTICLE ONLY (Non-Binding):** Shall the Isle La Motte Select board, and other Town public bodies, approve the use of technology that permits the public attendance at all meetings, through electronic means (i.e.: Zoom)? Yes ___ No ___

Article 7. Will the legal voters of the Town approve the sum of \$6,000.00 to the Cemetery Commission for the restoration of graves?

Article 8. Will the legal voters of the Town approve the sum of \$2,500.00 to the UVM Home Health & Hospice (VNA)?


Article 9. Will the legal voters of the Town approve the sum of \$1,500.00 for Island Arts?

Article 10. Will the legal voters of the Town approve the sum of \$1,000.00 for Isle La Motte Recreation Department?

Article 11. Will the legal voters of the Town approve the sum of \$1,000.00 for Agewell?
