Selectboard Special Meeting Minutes - 2026 budget

09 December 2025

PRESENT: Chair, Peter Brzozowy, Vice-Chair, Pat Treckman, Joe Deller, Mary-Catherine Graziano, Cary Sandvig, Treasurer, Mary LaBrecque, Selectboard Clerk, Donna Bohannon

Call to Order – Meeting was called to order at 6:00PM by Chair, Peter Brzozowy

Additions/Adjustments – Two additions were addressed at the start of the meeting.

- Addition #1: Peter Brzozowy informed all present that Karen Brunner and Andrea Carbone completed the tentative contract for the plumber, Bernie Gage and would like board approval to send it to the town attorney for review before sending it to the contractor.
 - There was some discussion about the need for the town attorney to review and it was agreed by all that given the amount of the contract, it should be reviewed by a legal expert before sending it to the contractor.
 - Peter Brzozowy motioned to authorize Karen to send the contract to the town attorney for review – seconded by Pat Treckman – all in favor – motion carried.
- Addition #2: Selectboard Assistant asked on behalf of the following five town groups: The Historical Society, Preservation Trust, Isle La Motte Community Organization (ILMCO), The Isle La Motte Library, and the Isle La Motte Fire Chief, if their submissions would be included in the town report again this year.
 - The Board agreed that as local groups, if they submit a report, it would be included in the Town Report.

Errors and Omissions – Mary LaBrecque, Treasurer and Lister, reported to all present that there was an error made by the Listers.

- Mary reported that a camper was accidentally inactivated before tax bills went out.
- The owner of the camper inquired about the tax bill they expected to receive.
- The value of the camper is \$3,600, which will result in an additional \$ 80 in tax revenue.
- Peter Brzozowy motioned to approve the errors and omissions request – seconded by Pat Treckman – all in favor – motion carried.

Budget work – Cary Sandvig began by recapping what was agreed on at the previous meetings.

- There was some discussion about various items they had discussed previously, such as work at the Brothers Camp, adding a category for grants and adding additional areas to the mowing contract.
- There was also some discussion about asking the auditing firm to explain the budget to them as they some of the numbers didn't make sense and they would like to have a better understanding of those numbers.
- The Board continued to discuss tentative figures for the budget items
- No final decisions were made at this meeting and budget talks will resume at a date to be determined.

Adjourn – At 8:03PM Peter Brzozowy motioned to adjourn – seconded by Cary Sandvig – all in favor – motion carried – meeting adjourned.
